

## 2018-2019 V1 VERIFICATION WORKSHEET FOR DEPENDENT STUDENTS

Your 2018–2019 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information, we will compare your FAFSA with the information on this institutional verification document and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and a parent whose information was reported on the FAFSA must complete and sign this institutional verification documents, and submit the form and other required documents to us. I, the student have filed a 2016 income tax return but am <u>unable or choose not to</u> use the IRS Data Retrieval Tool in FAFSA on the Web, and will submit to the school a **2016 IRS tax return transcript** (a photocopy of the income tax return is not acceptable). *To obtain a free IRS tax return transcript, go to <u>www.IRS.gov</u> and click on the "Get Transcript of Your Tax Records" link under "Tools." If you create an account before proceeding to the additional steps of requesting a tax transcript, you should be able to download and print your transcript immediately, or request the transcript be mailed to your address on record. Alternatively, you may call 1-800-908-9946, or contact your local IRS office to see if you may pick up a copy. Make sure to request the "IRS tax return transcript." You will need the Social Security Number (or the IRS individual taxpayer identification number) and date of birth of the first person listed on the 2016 IRS income tax return, and the address on file with the IRS (normally this will be the address used when the 2016 tax return was filed). Adequate time from the date of filing your tax return (up to three weeks for IRS electronic filers, and up to eleven weeks for paper IRS filers) is necessary prior to requesting an IRS tax return transcript. Verification cannot be completed until the IRS tax return transcript has been submitted to the student's school. . I understand I must also provide all W-2 copies with this form.*

The parents have filed a 2016 income tax return but am <u>unable or choose not to</u> use the IRS Data Retrieval Tool in FAFSA on the Web, and will submit to the school a **2016 IRS tax return transcript** (a photocopy of the income tax return is not acceptable). *To obtain a free IRS tax return transcript, go to <u>www.IRS.gov</u> and click on the "Get Transcript of Your Tax Records" link under "Tools. The IRS estimates allowing a minimum of 5 business days for your receipt of an available requested transcript. Verification cannot be completed until the IRS tax return transcript has been submitted to the student's school. . The parents understand they must also provide all W-2 copies with this form.* 

The parents are <u>unable or choose not to use</u> the IRS Data Retrieval Tool in *FAFSA on the Web*, and instead will provide the school a **2016 IRS Tax Return Transcript(s)**. If the parents filed separate 2016 IRS income tax returns, **2016 IRS Tax Return Transcripts** must be provided for both. **The parents understand they must also provide all W-2 copies with this form**.
